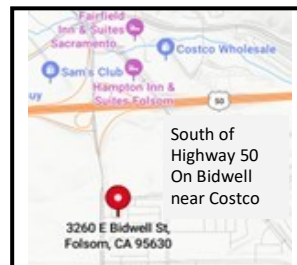
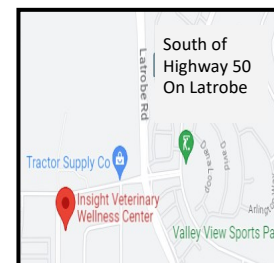

NOTICE TO EXHIBITORS

- ◆ **Check-In begins at 8:30 a.m. Trial site is open at 8:00 a.m. for set-ups. Trial begins at 9:00 a.m. PST. Judging will commence per in the Trail Schedule as shown in the Exhibitor Confirmation.**
- ◆ **Exhibitor Confirmations will be emailed to exhibitors 2 days prior to the Trial. Contact the Trial Secretary if you do not receive it.**
- ◆ **Running Order will be posted prior to judging commencing.**
- ◆ Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- ◆ All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment.
- ◆ e-Mail entries are only valid after receipt of entry fees.
- ◆ **Competition Canine** reserves the right to refuse any entry without cause or explanation.
- ◆ Checks must be made payable to **Comp K9**.
- ◆ No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused, or barred from competition by decision of the Trial Committee.
- ◆ It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may including violation of any COVID requirements, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- ◆ Refunds will be mailed 7 days after the event.
- ◆ All dogs must be on leash at all times except when competing.
- ◆ Run Order will be posted outside the entry door. Exhibitors handling multiple dogs will be accommodated as well as possible within their class(es).
- ◆ Exhibitors are responsible for being in the staging area when it is their turn to run.
- ◆ **There is an exercise area behind the gates plus a small grass area on the east side of the building. Use these areas ONLY.**
- ◆ **Please be courteous and pick up after your dog.**
- ◆ **Do NOT park directly in front of Geartooth Brewery.**
- ◆ There is no food on site but restaurants, deli, and fast food nearby.
- ◆ Qualifying, Placement and New Title Ribbons will be awarded at conclusion of a class or the trial.

DIRECTIONS TO SITE

Take Highway 50 to the Placerville Drive, Forni Road exit. Go to your right back over the highway to the 3rd light. (Raley's, Wells Fargo & El Dorado Savings at this corner). Turn left at the light and make a right turn at the second driveway on your right. You are facing 7533 Green Valley Road. Park anywhere in the lot. The Training Center is to your left in a large building behind the front 7533 building.

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations published for this event and any decision made in accord with them and further agree to be bound by this Agreement. I (we) agree that the club or ACT Evaluator, holding this event has the right to refuse this entry for cause which the club or ACT Evaluator shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. INSTRUCTIONS

Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. **AKC Canine PartnersSM** applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the **AKC Canine PartnersSM** program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
